The tenders shall be received by the DSWO, Bhadrak on or before 31.5.2010 up to 1.00 PM through Tender Box kept in office of the DSWO, Bhadrak and will be opened in same day, i.e,31.5.10 by the Collector, Bhadrak or any officer authorized by the Collector at 4.00 PM in the Conference Hall of Collectorate, Bhadrak in the presence of Tender Committee members and tenderers or their representatives. **TENDER NOTICE FOR APPOINTMENT OF TRANSPORTING AGENT UNDER  
SUPPLEMENTARY NUTRITION PROGRAMME FOR THE YEAR 2010-11.**


1. Sealed tenders in the prescribed form for transportation of Rice under SNP in respect of Bhadrak District are invited from the intending Registered/ Authorized licensing Transport Contractors/ Agents for undertaking to transport of Rice on the aforesaid programme in respect of Bhadrak District for the year 2010-11.
2. The tender will be received by DSWO, Bhadrak on behalf of the Collector, Bhadrak till 1.00 PM on or before 31.5.2010 and will be opened on the same day i.e on 31.5.2010 at 4 PM in presence of the Members of the Tender Committee and tenderers or their authorized representatives. No tender paper shall be received by hand.
3. The detailed tender papers regarding terms & conditions can be downloaded on the website i.e. [www.bhadrak.nic.in](http://www.bhadrak.nic.in). The tender paper can be obtained on payment of Rs. 5000/- towards cost of tender documents which is non-refundable.

The WSHGs purchasing tender paper has to produce original group pass book along with certificate from the concerned CDPO regarding group functioning. The tender received beyond the stipulated date and time will not be taken into consideration.

4. The tenderer shall be required to lift rice under SNP from F.C.I godown and transport the same directly to ICDS points in the District as per Way bills issued by the DSWO, Bhadrak.
5. The tender paper should be filed by the tenderer properly and legibly without any correction/ overwriting. The rates and units should be written both in words and figures in the tender form. The rate quoted by the tenderer should be final and tenderer shall not be allowed to change anything under any circumstance and it should be valid for the year 2010-11. The rate of transportation per quintal from FCI godown to ICDS points including loading, unloading and other incidental charges should be mentioned in Annexure- I.
6. The following original/Xerox copy of documents duly attested by the Gazetted Officer should be produced by the tenderer along with the tender paper. In absence of any document/ papers in the tender form will be liable rejection by the competent authority.
  - I. The original money receipt of the tender paper purchased.
  - II. The Agent license owned by the tenderer under Odisha Motor Vehicle ( Licensing of Agent) Rules'1990 should be produced in the tender form.
  - III. Earnest money should be deposited by the tenderer of Rs.9,00,000/- (Rupees nine Lakhs) only in shape of NSC/ Term deposit duly pledged in favour of the Collector, Bhadrak and it will be enclosed along with tender paper. No tenderer shall be allowed to withdraw his Earnest Money Deposited by him until the tender is finalized. The earnest money will be refunded to the unsuccessful tenderer after completion of selection by the Tender Committee.
  - IV. EMD by the successful tenderer will stand converted to security deposit which will be refunded after successful completion of contract period and audit of such accounts of the Transporting Agent. The whole or part of the security deposit will be forfeited for irregular performance or break of any terms & conditions of agreement during the contract period.
  - V. The tenderer should produce Income Tax, PAN card with the tender form.
  - VI. The recent solvency certificate ( 2009-10/ 2010-11) of Rs.20,00,000/- (Rupees twenty lakhs) only obtained from the competent authority.
  - VII. The tenderer should mention the number of trucks under him for transportation and produce the proof of said vehicle i.e Xerox copy of R.C books in case of owned by him or in case of hire basis should be produced

the copy of lease agreement ( At least the documents for two nos. of trucks should be produced in the tender form)

- VIII. The tenderer should file an affidavit either from the Executive Magistrate or from the Notary in support of that, he/she has no criminal cases/ criminal back ground.
- IX. The successful tenderer shall execute an agreement (registered) with the Collector & Dist. Magistrate, Bhadrak as per terms and conditions. The said agreement shall be executed by the tender at his/ her own cost within 7 days of the intimation of acceptance of tender.
- X. 1% of the bill amount shall be deducted at the time of payment of the bill as security deposit.
- XI. The tenderer may attach any certificate issued by Govt/ Semi-Govt about past experience and performance.
- XII. The authority shall reserves the right to reject any or all tenders received without assigning any reason thereof.



## NATURE OF WORK AND PAYMENT

1. The work is to be carried on with due diligence and in accordance with the instructions to be issued from time to time by the Collector/ DSWO, Bhadrak.
2. The bills will be submitted by the TA at least once in a month before the DSWO on completion of delivery of stock as per orders of the competent authority on production of waybills duly acknowledged by the recipients of stock to whom it concerned. The DSWO shall have the right to deduct and adjust any amount found recoverable towards loss/ damage or both of the food stuff i.e. Rice.
3. The Collector has got right to terminate the contract for violation of terms of agreement.
4. Payment shall be made as per approved rate incorporated in the agreement.
5. No request for enhancement of approved rates shall be entertained during the term of agreement.
6. The SNP transporting agent will be liable to pay demurrage charges in case he fails to lift the stock within the stipulated period.
