Sealed tenders in plain paper are invited from the intending Registered Authorized Dealers or Suppliers for supply of Double Dicker and Single Bed Cots as per specifications, design and drawing approved by the Govt.(Copy enclosed) of light blue colour for use in ST/SC hostels at Kanpur R/S(B. Pokhri Block), Ranjeet R/S and Dahapania High School(Tihidi Block). The Supplier shall submit the following documents along with the tender papers .

1. Attested photo copy of the up to date sales tax clearance certificate (S.T.C.C.) & sales tax Registration Certificate (TIN OR SRIN NO)
2. Attested copy of the PAN CARD (which should be in his name) and Income Tax Clearance Certificate.
3. The following terms and conditions of the tender shall be as follows:-
 - i. The tenders shall deposit an Earnest Money amounting to Rs 5000/- (Rupees five thousands) only in the office of the District Welfare Officer, Bhadrak on or before the last date of submission of tender paper with proper address and contact number.
 - ii. The inclusive of all taxes should be quoted as per specific brand ,design and Drawing approved by the Govt.
 - iii. The sealed tenders shall be received by 10.02.2011.(5PM) through Registered Post /in hand at the office of the DWO, Bhadrak. The rates should be clearly mentioned on the tender paper and duly signed by the tenderer concerned otherwise the tender is liable to be rejected..
 - iv. The tender will be opened on 11.02 .2011 at...11. A M ..by the Distict Level Purchase Committee in the Office Chamber of Collector & District Magistrate, Bhadrak.
 - v. The District Level Purchase Committee shall not be bound to accept the lowest rate ,but the acceptance of the tender shall be based on the best quality of the materials .The finally accepted tender shall strictly confirm to the approved rates and the approved design while supplying.
 - vi. The earnest money deposited by the unsuccessful tenderers will be returned to them only after finalization of tender by the District Level Purchase Committee.
 - vii. In case the supply of the cots found to be poor/sub-standard quality Contrary to specification, design, and drawing the supply order will be cancelled and the earnest money deposited shall be forfeited.
 - viii. The finally accepted tender shall supply the cots to the destination point at their own cost failing which penalty will be charged as decided by the Collector & District Magistrate-cum-Chairperson.

The date and place of delivery will be fixed by the Committee.

- ix. While making payment after receipt of the cots ,10% of the cost of the Cots as security money shall be withheld till clearance and supply of cots .
- x. Order will be placed by DWO, Bhadrak and the number of cots to be supplied may increase or decrease subject to availability of funds.
- xi. The undersigned reserves the right to accept or reject any or all tenders without assigning any reason thereof.
