The tender shall be received by the DSWO, Bhadrak till 1 PM on 6.5.2011 through Tender Box kept in office of the DSWO, Bhadrak and will be opened on same day, i.e. 6.5.2011 at 4 PM by the Collector, Bhadrak or any officer authorized by the Collector in the Conference Hall of Collectorate, Bhadrak in the presence of Tender Committee members and tenderers or their representatives. SUPPLEMENTARY NUTRITION PROGRAMME (SNP) IN BHADRAK DISTRICT FOR
THE YEAR 2011-12.**

Sealed tenders for appointment of Transporting Agent are invited from the intending Registered firms/ Co- operatives/ Authorized licensing Transporting Contractors/ Agents/ WSHGs for undertaking transport of Rice under SNP in Bhadrak District for the year 2011-12. The approximate quantity of rice to be handled in a year and approximate value of the rice in the Govt. rate are as follows:-

Approximate Quantity of Rice in Quintals	: Q. 56400.00
Approximate value of Rice	: Rs.3,18,66,000/-

The tender will be received by DSWO, Bhadrak on behalf of the Collector, Bhadrak till 1.00 PM on 6.5.2011 and will be opened on the same day i.e on 6.5.2011 at 4 P.M.in presence of the tenderers or their authorized representatives. The tender paper received beyond the date & time shall be liable for rejection. No tender paper shall be received by hand.

The tender papers should be submitted in sealed cover superscribing in block capital letters such as "TENDER PAPER FOR APPOINTMENT OF TRANSPORTING AGENT UNDER SNP IN BHADRAK DISTRICT FOR THE YEAR 2011-12".

The detailed tender papers along with the terms & conditions can be downloaded on the website i.e. www.bhadrak.nic.in. The tender paper can be obtained on payment of Rs. 5000/- towards cost of tender documents which is non-refundable.

The WSHG purchasing tender paper has to produce original group pass book along with certificate from the concerned CDPO regarding group functioning. The tender received beyond the stipulated date and time will not be taken into consideration.

TERMS & CONDITIONS OF THE TENDER.

1. The tender paper should be filed by the tenderer properly and legibly without any correction/ overwriting. The rates and units should be written both in words and figures in the tender form. The rate quoted by the tenderer should be final and tenderer shall not be allowed to change anything under any circumstances. The transportation cost per quintal including loading, unloading and other incidental charges irrespective of KMs from FCI godown to each Anganwadi points and SHG/federation engaged for THR preparation at ICDS level should be mentioned in Annexure- I.

2. No individual , company, firm, corporation shall participate in the tender process unless it obtains or possess valid agents license under OMV (Licensing Agents) Rules 1990.
3. The successful tender shall be required to lift rice from FCI depot & transport the same to different Anganwadi Centres and SHG/federation engaged for THR preparation at ICDS level as per the direction of the Collector/ DSWO, Bhadrak within the specified period on the same date without any storage during transit.
4. It is the responsibility of the transporting agent to lift the rice from FCI Depot on proper weighment and deliver the same to the AWWs/ WSHGs on proper weighment in the presence of the members of the Janch Committee/ SHG/ Federation/ Mothers' Committee as the case may be. The transporter shall carry weighing machine in the truck for weighment which must be sealed and stamped by the Inspector of Legal Metrology, Bhadrak. The agent will be held responsible for delivery of the stock, any shortage and damage noticed during transit. The quality and quantity of the rice being transported may be inspected by the Govt. Officials authorized by Collector during transit and also at the delivery point. There shall not be any change both in quality and quantity of the rice during transportation by the transporting agent and for any shortcomings in this front the transporting agent shall be responsible and this shall be treated as misappropriation by the transporting agent. If any misappropriation is found during inspection or otherwise a penalty shall be levied which would be equivalent to 10 times of the cost of misappropriated food grains apart from initiating criminal cases.
- 5- The following original/ Xerox copy of documents duly attested by the Gazetted officer should be produced by the tenderer along with the tender paper. In absence of any document/ papers in the tender form will be liable for rejection by the competent authority.
 - a. Original tender paper duly signed by the tenderer as token of acceptance of the terms & condition of the tender.
 - b. The original money receipt of the tender paper purchased.
 - c. The Agent license owned by the tenderer under Odisha Motor Vehicle (Licensing of Agent) Rules'1990 (For Bhadrak District) should be produced in the tender form.

- d. Earnest money should be deposited by the tenderer of Rs. 3,19,000.00 (Rupees three lakhs nineteen thousand) only in shape of NSC/ Term deposit duly pledged in favour of the Collector, Bhadrak and it will be enclosed along with tender paper. No tenderer shall be allowed to withdraw his Earnest Money Deposited by him until the tender is finalized. The earnest money will be refunded to the unsuccessful tenderer after completion of selection by the Tender Committee.
 - e. Earnest money deposited by the successful tenderer will stand converted to security deposit which will be refunded after successful completion of contract period and audit of such accounts of the Transporting Agent. The whole or part of the security deposit will be forfeited for irregular performance or break of any terms & conditions of agreement during the contract period.
 - f. The tenderer should produce Income Tax, PAN card with the tender form.
 - g. The recent solvency certificate (2011-12) of Rs.20,00,000.00 (Rupees twenty lakh) only obtained from the competent authority or Bank guarantee of Rs.20,00,000.00 (Rupees twenty lakh) only from nationalized Bank.
 - h. The tenderer should mention the number of trucks under him for transportation and produce the proof of said vehicle i.e Xerox copy of R.C books in case of owned by him or in case of hire basis should be produced the copy of lease agreement (At least the documents for two nos. of trucks should be produced in the tender form)
 - i. The tenderer should file an affidavit either from the Executive Magistrate or from the Notary in support of that, he/she has no criminal cases/ criminal back ground.
6. The successful tenderer shall execute an agreement (registered/ Notary) with the Collector & Dist. Magistrate, Bhadrak as per terms and conditions. The said agreement shall be executed by the tenderer at his/ her own cost within 7 days of the intimation of acceptance of tender.

- 7- The tenderer may attach any certificate issued by govt/ Semi-govt about past experience and performance.
- 8- 2.06% of the bill amount shall be deducted at the time of payment of the bill as TDS.
- 9- Collector has got right to terminate the contract for violation of terms of agreement
- 10- The transporting agent will be liable to pay demurrage charges in case he fails to lift the stock with the stipulated period.
- 11- Payment shall be made against submission of bills on completion of the delivery of the stocks as per the orders of competent authority on production of printed serially numbered delivery challans duly acknowledged by the recipient of the stock to whom it concerned and as per the approved rate in the agreement. The District Social Welfare Officer, Bhadrak shall have the right to deduct and adjust any amount found recoverable towards loss and damage or both. The payment will be made subject to availability of funds under head transportation charges under SNP and no advance payment will be made.
- 12- In case of violation of conditions of Tender the Agent will be booked under IPC, Essential Commodities Act. Prevention of Food Adulteration Act and Prevention of Black Marketing Act.
- 13- The authority reserves right to reject any or all tenders received without assigning any reason thereof.
