The detail Tender Call Notice along with tender documents will be available from the Official Web Site of Govt. of India [www.bhadrak.nic.in](http://www.bhadrak.nic.in) for the works at sl.No-1 to 6 **from 10 A.M. of 29.03.2011. to 4 P.M. of 11.04.2011.** The Intending tenderers may down load the tender documents from the above web site and to submit the cost of tender paper (non-refundable) in shape of D.D/P.O drawn in any Nationalised Bank in favour of Chairman, R.M.C., Bhadrak payable at Bhadrak as per the "column 6" of the tender notice in a separate envelope super scribing as **"Cost of tender documents down loaded from the website"** alongwith each tender.

The Last date of receipt of Tender paper is **13.04.2011 up to 2.00 P.M.** The tender paper should be submitted by Registered post/Speed post only addressing to the Chairman, **Regulated Market Committee, Bhadrak, At-Salandi by pass P.O/ Dist-Bhadrak.** The envelop containing tender documents must be superscribed with "Tender for the Work R.M.C., Bhadrak". Tender received after due date & time will not be accepted. The authority is not responsible for any postal delay or loss of tender documents.

The tenderer should go through the detail tender call notice along with term and condition before submitting their tender documents.

The Chairman, R.M.C., Bhadrak will open the tender on dt. 15.04.2011 at 11 A.M. in the Office of the Collector & District magistrate, Bhadrak.

In case, date of opening is declared as holiday the tender will be opened on the next working day in the same time and venue.

2. Tenders in complete shape must be accompanied with attested copies of valid registration certificate, PAN Card, VATCC, alongwith original money receipt/Draft/Pay order towards purchase of Tender paper & required EMD in shape of Demand draft/Pay order/post office saving account/N.S.C/K.V.P/post office time deposit, pledged in favour of **Chairman RMC Bhadrak** as prescribed detailed in column(4). The EMD should be deposited for each work separately. No adjustment of EMD from one work to another work will be entertained. Tenders without required EMD as detailed above in column (4) will be liable for rejection. Necessary concession to the Engineering / SC/ST and Physical handicapped contractors are applicable as per rules in force.
3. **In case of less quoted tenders, the Tenderer has to deposit the differential amount (between the tender cost and quoted cost) at the time of submitting tender paper as additional performance security** in shape of Demand draft/Pay order/post office saving account/N.S.C/K.V.P/post office time deposit, pledged in favour of the **Chairman, RMC Bhadrak** . In case of non submission of differential amount at the time of submitting tenders the tender shall be treated as rejected.
4. Each tender shall be accompanied by original affidavit regarding authentication of documents, furnished by the tenderer failing which tender will be liable for rejection.
5. These are time-bound works and are to be completed within this stipulated time. The respective bidders are advised to study the scope of work and survey the site for constraints if any and assess their bid capacity and capability before submitting their tenders.
6. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
